

Frameworks are an important way for healthcare organisations to ensure they maintain quality and achieve value for money in the products and services they procure. ### 1. What is a framework?

# Frameworks are often used in the public sector to ascertain consistent terms, service levels and, leverage volume to unlock discounts.

Frameworks can be compiled by an individual organisation, however, more frequently, they are compiled by overarching bodies such as the HSE, NHS or HSC and can be used by organisations that are part of those bodies.

### Frameworks set out:

- the requirements for specific products or services required by the organisation(s) covered by the framework
- the terms and conditions under which the products or services are to be delivered
- the service levels and corresponding Key Performance Indicators (KPIs) that suppliers need to adhere to.

Importantly, they also provide an approved and vetted list of suppliers with the expertise and depth to deliver those products or services to the required standards.

Your organisation may then work with these approved suppliers to deliver the specific products or services under the pre-approved terms of the framework. Therefore, no negotiation(s) or lengthy contractual reviews are required.

Frameworks run for a set period of time and are regularly reviewed by the overarching body to ensure they continue to deliver value for money.





### 2. How do frameworks help healthcare organisations?

Frameworks help healthcare organisations in several ways, including:

## **2.1** Frameworks give buyers confidence in their appointed supplier

When evaluating and appointing potential suppliers to a framework, all relevant criteria (such as quality, price, governance, sustainability and ability to deliver) are considered. The rigorous framework evaluation process gives you the confidence that all suppliers who have been awarded on the framework meet the stipulated standards.

# **2.2** Frameworks simplify the process of awarding contracts to suppliers

Because you don't have to carry out a formal procurement process, e.g. Publish a contract via OJEU, Contracts Finder etc., you can save time and be rest assured that you'll have access to pre-vetted supplier(s), mutually protective terms and competitive pricing.

### **2.3** Frameworks help organisations to benefit from economies of scale

Frameworks set out prices for the products or service to be delivered. Prices relate to the overall framework volume rather than an individual buyer's requirements, which mean prices for a product or service can be lower than if they if they were procured on the open market.



### **3.** Tier 1, Tier 2, Multi-Supplier Panels – what do they all mean?

Often, a framework will feature several suppliers This is referred to as a multisupplier panel. Suppliers on a framework may also be listed in tiers. Suppliers who have been awarded Tier 1 status, have been determined by the awarding body as the supplier who have the strength and scale to best meet your needs.

## **5.** How do I select and engage with a framework supplier?

### This both depends on 'The Framework Management Authority' and the type of healthcare recruitment you are looking for.

For the HSE (in **Ireland**) there is a mandate for the use of frameworks across temporary and permanent needs, and therefore all related requirements should go via your procurements department (if applicable) as the process is managed centrally. There are similar arrangements for **Northern Ireland**, where temporary requirements are broadcasted centrally to the relevant Tiers for temporary needs, and for permanent vacancies to be filled internationally a central approach is taken.

For the **UK** mainland frameworks there is a higher degree of choice and flexibility, and requirements can be issued to all approved suppliers, directly awarded or a mini competition can be initiated.
